SUMMARY NO. 1370-OR (Introduced by Dean LeBlanc, District 8)

An Ordinance to amend Article I of Chapter 28 of the St. Martin Parish Code of Ordinances by the repeal, amendment, revision, and/or re-enactment of Sections 28-12 and 28-21; and the enactment of Sections 28-25 to 28-30 thereto, all relative to the prohibition of the unregulated and unauthorized use of designated areas of the Paul Angelle Park; and providing for penalties associated therewith.

SUMMARY NO. 1371-OR (Introduced by Dean LeBlanc, District 8)

An Ordinance setting the speed limit to 15 mph on Bodo Road, located in District 8.

SUMMARY NO. 1372-OR (Introduced by Dean LeBlanc, District 8)

An Ordinance to amend Chapter 22 of the St. Martin Parish Code of Ordinances by the enactment of Section 22-17 thereto, all relative to the exemption of Bordelon Road and Melvin Dupuis Road from load limits only as regards agricultural pursuits.
