WHEREAS, pursuant to the RESTORE Act, the St. Martin Parish Government has been granted funding for the construction of floating docks at both the Clayton Boudreaux Memorial Park and Uncle Dick Davis Park, all in St. Martin Parish, Louisiana; and

WHEREAS, the project is known as "The New Floating Docks Project at Clayton Boudreaux Memorial Park and Uncle Dick Davis Park" (hereinafter "The Project"); and

WHEREAS, in connection with The Project, it is necessary that the St. Martin Parish Government enter into an agreement with the Office of Gulf Coast Restoration, Department of Treasury of the United States establishing that each of the floating docks will be subject to continued use by the public:

BE IT FURTHER ORDAINED by the St. Martin Parish Council that the Parish President be and is hereby authorized, empowered, and directed to incorporate in any such agreement such other terms, conditions, and provisions as he may deem necessary and fit in order to effectuate the above and foregoing edict.

A RESOLUTION AUTHORIZING THE FILING OF AN APPLICATION WITH THE LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT FOR A GRANT UNDER 49 CFR 5311, NON-URBANIZED AREA FORMULA PROGRAM AND/OR 49 CFR 5309, DISCRETIONARY CAPITAL PROGRAM.

WHEREAS, the Secretary of Transportation and Development is authorized to make grants for mass transportation projects; and

WHEREAS, the contract for financial assistance will impose certain obligations upon the applicant, including the provisions by it of the local share of project costs; and

WHEREAS, it is required by the Louisiana Department of Transportation and Development in accord with the provisions of Title VI of the Civil Rights Act of 1964, that in connection with the filing of an application for assistance that it will comply with Title VI of the Civil Rights Act of 1964 and the U.S. Department of Transportation requirements thereunder; and

WHEREAS, it is the goal of the Applicant that minority business enterprise be utilized to the fullest extent possible in connection with this project, and that definitive procedures shall be established and administered to ensure that minority businesses shall have the maximum feasible opportunity to compete for contracts when procuring construction contracts, supplies, equipment, or consultant and other services:

A RESOLUTION SUPPORTING THE GRANTING OF ASSISTANCE TO THE DEEP WATER BASIN CRAWFISH INDUSTRY UNDER THE CARES ACT.

WHEREAS, the United States Congress has enacted the Coronavirus Aid, Relief, and Economic Security Act ("CARES Act"); and

WHEREAS, the CARES Act provides a substantial stimulus package to mitigate the economical effects of the COVID-19 pandemic; and

WHEREAS, the Louisiana Crawfish industry in an integral component of the Louisiana Acquaculture; and

WHEREAS, the harvesting of crawfish is a seasonable industry with its peak being in the Spring and early summer months; and

WHEREAS, the COVID-19 pandemic has resulted in the closure of restaurants and the diminishing of substantial gatherings such as festivals and social events, all of which provide essential markets for the Louisiana crawfish industry; and

WHEREAS, the portion of the crawfish industry which harvest from the natural waters of the State of Louisiana and/or the United States have been especially negatively impacted by the COVID-19 pandemic; and

WHEREAS, the financial impact on those fishermen who harvest from natural waters have been impacted to a degree equal to, if not greater than, those fishermen who harvest from "farm raised" sources; and

WHEREAS, there is no rational basis to distinguish between the fishermen who harvest from natural waters and those who harvest from farm raised sources, especially as regards recovery and relief under the CARES Act; and

WHEREAS, it is of critical import that the segment of the Louisiana Aquaculture Industry that includes those crawfishermen who harvest from natural waters be eligible for relief under the CARES Act to the same extent as other segments of the crawfish industry:

NOW, THEREFORE, BE IT RESOLVED that the ST. MARTIN PARISH COUNCIL and PARISH PRESIDENT do hereby publicly declare and publish its unconditional support for providing relief under the CARES Act to the Louisiana Crawfishermen who harvest from the natural waters of the State of Louisiana and/or United States, finding that the negative impact of the COVID-19 pandemic on that industry is substantial and verifiable. Moreover, the foregoing have determined that the COVID-19 pandemic has been equally devastating to those fishermen as it has been to any other segment of the Louisiana Acquaculture industry.

### SUMMARY NO. 1293-OR (Introduced by Brook Champagne, District 6)

An Ordinance of the St. Martin Parish Council amending and re-enacting Section 4.15 of the Personnel Policies and Procedures Manual of St. Martin Parish Government relating to Health, Accident and Life Insurance Coverage to provide that members of the St. Martin Parish Council shall be eligible to participate in the St. Martin Parish Government Group Health, Accident and Life Insurance plan only upon the payment by them of the entirety of the monthly premiums due and owing as a result of their participation in such plan; and otherwise to provide with respect thereto.

Prior to adjournment, Parish President Chester Cedars briefed the Council Members on a few matters. Parish President Chester Cedars stated the first St. Martin Parish Government employee tested positive for COVID-19. All procedures regarding this was followed through. Parish

President Chester Cedars also noted the water level is dropping in Lower St. Martin Parish.
